PROCEDURE

- 1. Prepare Phase W1 and O1 separately, and heat to 70-75 °C.
- 2. Add Phase W1 to O1 under stirring until homogenizing, and keep temperature at 80-85°C.
- 3. Add Phase A into the main tank after cooling (<40 °C).
- 4. Mix well.
