PROCEDURE

- 1. Prepare Phase O1 and Phase W1 separately and heat to 70-75°C.
- 2. Add Phase W1 to Phase O1 and homogenize using a high-speed homogenizer.
- 3. Add Phase A one by one when the temperature is below 40°C and mix well.
- 4. Finally, add Phase B and stir until evenly distributed.
