PROCEDURE

1. Premix and heat phase O1 to about 90°C.
2. Add phase O2 to O1 and mix well.
3. Prepare phase O3, make sure the pigment is well dispersed then add to the main tank.
4. Pour the hot liquid to the vessel and wait for the sample cooling down.
