PROCEDURE

- 1. Prepare Phase A and Phase B separately and heat to 70-75°C till all the ingredients melt.
- 2. Add Phase B to A under homogenizing for a couple of minutes. Then cool down under stirring.
- 3. Prepare Phase C separately.
- 4. Add Phase C to Phase A+B under stirring.
- 5. Add Phase D, with the temperature below to 40°C.
